



SVHC DECLARATION

The Candidate List of Substances of Very High Concern (SVHC) published by the European Chemicals Agency (ECHA) on and before July 08, 2021 contains two hundred and nineteen substances. According to Article 33(1) of the Regulation (EC) No. 1907/2006, manufacturers and importers of articles are required to notify their customers of the presence of any Substances of Very High Concern (SVHC) in their products exceeding 0.1% weight by weight (w/w) and provide instructions on safe use of the product including as a minimum the name of the substance in the Candidate List.

IMERYS synthetic graphite products are not directly addressed by this Candidate List and furthermore none of the substances listed in the SVHC list are intentionally added/used by IMERYS Graphite & Carbon in any of its products. Regardless, we perform analyses at least yearly for selected representative samples for the products listed below at an independent external laboratory.
